A PSW team also participated in Dubai Expo 2020 in February this year and engaged with overseas Pakistani trade, technology partners, and other stakeholders.

As the company evolves, we are constantly updating and streamlining our internal processes related to HR, procurements, and finances based on the feedback received from the PSW team. There are exciting and challenging times ahead as we expand our services, integrate with more departments, and push forward with transformational initiatives that will enhance Pakistan's trade competitiveness. ### **PSW Launches Helpline**

Pakistan Single Window's digital transformation aims at reducing the time and cost of doing business by digitalizing Pakistan's cross-border trade and eliminating paper-based manual processes. As part of this endeavor, PSW launched an exclusive support center that provides 24/7 assistance via a helpline 021 111 111 779, social media integration, and an email <a href="mailto:support@psw.gov.pk">support@psw.gov.pk</a>. to make it easier for traders, entrepreneurs, and businesses in Pakistan to reach out to the administration, to seek technical support and access a range of resources for their trade.

#### **E-Form Elimination Benefits Traders**

PSW took another step toward empowering e-commerce and increasing exports in Pakistan. The State Bank of Pakistan (SBP) eliminated the requirement of Electronic Form-E (EFE) to facilitate exports through Pakistan Single Window. Here are the benefits for Exporters after the implementation of E-form elimination by PSW:

- · One contract can be used for multiple declarations
- One Letter of Credit L/c can be used for multiple declarations
- · Open account declarations can be filed without any financial instrument
- Physical movement of export cargo delinked from consignment-based permission in the shape of EEF issued by banks

# PSW is Paving the Way for Ease in Imports and Exports



PSW organized an orientation session for the members of the Salt Manufacturers Association of Pakistan. The session was attended by almost 50 participants who were briefed about PSW, and how the implementation of the Pakistan Single Window Act will facilitate Pakistan to broadly advance transparency, efficiency, and controls in imports, exports and transit trade on one hand, and meeting its international obligations of TFA and WTO on the other hand.

Participants were informed of the salient features offered by PSW including subscription, SD Exports, Elimination of E/I forms, AD Integration, and the process of bank profile registration that would help manufacturers by reducing time, cost, and complications associated with fulfillment of multiple paper-based regulatory requirements.

Pakistan Single Window initiated its global outreach through participation in the Expo 2020 Dubai. In this regard, PSW conducted several sessions focusing on trade, industry, business environment, and automation of business processes with the overseas Pakistani business community, diplomats, and international companies at the Pakistan Pavilion of Expo 2020. ### Pakistan Single Window Governing Council reviews PSW implementation



The PSW Governing Council reviewed the progress of PSW implementation. Federal Minister for Finance and Revenue Shaukat Tarin presided over the 3rd meeting of the PSW Governing Council (GC) in Islamabad. Syed Muhammad Tariq Huda, Secretary to the GC briefed the participants on the implementation status of previous decisions of the GC.

The CEO of PSW gave a presentation on the progress already made and highlighted key challenges. The GC was informed that the PSW program is on course to complete its 1st phase before the deadline of June 2022. The Federal Minister for Finance and Revenue expressed the government's complete support and commitment to the PSW initiative aimed at facilitating international trade in Pakistan.

Pakistan Single Window (PSW) launched the Trade Information Portal of Pakistan (TIPP) on March 31, with an aim to improve transparency and facilitate cross-border trade. PSW organized a preview session on TIPP at a local hotel before a group of public and private sector stakeholders in Karachi to mark the roll-out of the portal in compliance with the country's commitment to the WTO Trade Facilitation Agreement.

The portal is aimed at facilitating cross-border trade by providing complete trade-related information and guidance to individuals and businesses engaged in cross-trade. ## Plant Export Certification Digitized

PSW has launched a digital facility for getting the phytosanitary certificate, required for exports of plants and related products by the Department of Plant Protection (DPP).

The digitization of DPP certification will provide a seamless process for traders. The new online system will take over the current paper-based manual procedures of DPP under which around 5000 certificates are issued annually. PSW organized a workshop with the officials of the Department of Plant Protection - DPP aimed at facilitating the deployment of the PSW System.

Pakistan Single Window has successfully integrated 21 banks. The following banks joined us in the first quarter. Traders are no longer required to obtain Electronic Import/Export forms (EIF/EFE) for clearing consignments in Pakistan.
