I hope everyone had a blessed Eid-Al-Azha. We have witnessed remarkable progress in creating a more efficient and streamlined trade environment over the past year, and with great pride, I take this opportunity to share some exciting news regarding recent expansions and growth at PSW.

User adoption is at over 66,695, and our coverage in terms of locations, services, OGAs, and new modules continues to expand at a steady pace. Under Phase II of our rollout plan, our coverage has expanded to include the Mercantile Marine Department, the Marine Fisheries Department, the Ministry of Narcotics Control, and the Sindh Excise and Taxation Department while initial services for the Drug Regulatory Authority of Pakistan are also being rolled out. This expansion allows us to provide a more comprehensive and inclusive platform for trade facilitation, enabling a wider range of entities to benefit from our services. The increased participation of OGAs demonstrates the commitment of PSW and its partners to modernizing trade processes and promoting a business-friendly environment.

PSW is expanding its global footprint. Internationally, we continue to forge collaborative partnerships to boost trade ties and exports. We were recently in Tbilisi, Georgia, to share our experiences with our partners in the Central Asian region. We are also learning from Morocco's PortNet, a success story for implementing a Single Window and Port Community System in a developing country. Our newly acquired membership of the Pan Asian E-Commerce Alliance will enable us to participate in international projects involving B2B and B2G data exchange and connect with more economies through a seamless trade regulatory network.

Considering the trajectory PSW is on, we are led to assume greater responsibility as PSW becomes the bridge for Pakistan's digitalized integration into the international supply chain. This

THE PSW NETWORK CONTINUES TO EXPAND



PSW is making strides in digitalizing trade processes and is well ahead of planned timelines to achieve milestones identified for the Phase II rollout.

We are reshaping the cross-border trading landscape in Pakistan through extensive

engagement, collaboration, coordination, and cooperation amongst the different public and private sector entities involved with international trade. During the Phase II rollout, PSW is integrating the following regulatory bodies:

- DRAP-registration module

PSW has joined the Pan-Asian E-Commerce Alliance, making Pakistan the 18th Global Digital Trade Alliance Member and furthering PSW's agenda to enable cross-border trade facilitation and foster global collaboration. PAA announced the association at the 67th Steering Committee meeting in Auckland, New Zealand.

With alliances extending from Asia to Oceania, Europe, the Middle East, and the African region, Pakistan's membership will enhance PAA's global trade and logistics services reach in Asia through the development of trusted and reliable value-added IT infrastructure.

SUBSCRIBER MILESTONE: NUMBER OF PSW USERS CROSSES 66K IN THE FIRST HALF OF 2023

The usage and adoption of the PSW portal is growing, indicating a steady expansion of our network. With the number of subscribers on the Single Window System crossing 66,695 in June 2023, PSW is well on the way to reforming, modernizing, upgrading, and automating the face of cross-border trade in Pakistan.

PSW has also facilitated the trading community and public and private sector stakeholders with the electronic processing of 150,176 declarations and LPCOs.

PSW remains committed to providing state-of-the-art, digitalized trading services to meet the evolving needs of our growing trader community.

SINGLE WINDOW SYSTEM KNOWLEDGE-SHARING WITH MOROCCO

A delegation of six representatives from PSW visited PortNet S.A., the National Single Window, for seamless port and trade procedures in Morocco. PortNet is a tool specific to the Moroccan Government that aims to implement several cross-border trade-related sectoral strategies to improve the business climate, trade, port, and logistics competitiveness.

The visit provided a valuable opportunity to learn from the Port Authority in Morocco and for the PSW delegation to share learnings and observations from the implementation of the Port Community System (PCS) in Pakistan.



PSW EXTENDS ELECTRONIC ISSUANCE OF **PHYTOSANITARY CERTIFICATE** SERVICES TO THE **LAND BORDERS**

PSW has extended the electronic issuance of phytosanitary certificates by the Department of Plant Protection (DPP) to the land borders of Taftan, Torkham, and Chaman.

Under the new system, the phytosanitary certificate can be obtained by filing a Single Declaration (SD) through the PSW System .

In an era of globalization and regional cooperation, PSW is creating a digital trade ecosystem that extends beyond customs and regulatory clearances, fostering electronic data exchange among partner nations. Aligned with bilateral international transit and trade agreements, exchanging paperless data with neighboring countries will facilitate regional expansion by simplifying, modernizing, and standardizing export and import procedures.

Speaking to the Express Tribune, the CEO of PSW, Mr. Aftab Haider, highlighted, "PSW has established electronic connectivity with the National Single Window of China to facilitate the Electronic Exchange of Trade Data." Mr. Haider also revealed that PSW is integrating international exports with China by developing use cases for data exchange.

collaboration with MoMA, PSW has integrated two regulatory bodies: the Marine Fisheries Department (MFD) and the Mercantile Marine Department (MMD). The MFD deals with the export of fish and fishery products, and with PSW's MFD module, traders can perform the electronic submission of registration, premises, and renewal requests. The MMD regulates the export of used passenger and cargo ships, oil tankers, liquid cargo carriers, and fishing

trawlers. PSW's MMD module will facilitate the online processing of quality certificates, origin certificates, and health certificates associated with consignments from the MFD.

This initiative by PSW has a clear time-saving advantage and will provide ease of doing business. Engineer and Ship Surveyor -

Mercantile Maritime Department, Mr. Faisal, said, "PSW's integration with the MMD under the Ministry of Maritime Affairs will help the departments to reduce the paperwork, time, and cost associated with processing and clearance. This system will facilitate online communication between MMD officers and traders for document processing. Also, ship agents will be able to perform electronic document processing through a single click via the PSW portal."

UNIFIED REGISTRATION SYSTEM INTRODUCED FOR PESTICIDE IMPORT CLEARANCE

The Government of Pakistan (GoP) strictly enforces international Phytosanitary Regulations, which are crucial for traders to access global markets to import pesticide products. To facilitate compliance with phytosanitary regulations, PSW has introduced the Unified Registration System (URS), a digital system that enables the electronic registration and clearance of pesticide products allowing Pre-Shipment Inspection (PSI) companies to transmit documents and certificates electronically for verification.

The digitalized service by PSW for pesticide import will increase the availability of advanced pesticides contributing to improved agricultural productivity and ultimately fostering economic growth.

PAKISTAN WELCOMES BARTER TRADE WITH AFGHANISTAN, IRAN, AND RUSSIA UNDER PAKISTAN SINGLE WINDOW

Pakistan recently authorized barter trade with Iran, Afghanistan, and Russia under SRO 642 (I)/2023 to release pressure on dwindling foreign exchange reserves. As per the new rules, barter trade is allowed only for specific goods, including petroleum, coal, wheat, pulses, minerals, metals, gas, and other commodities.

The exchange of goods under the new B2B Barter Trade mechanism through PSW enables Pakistan to engage in mutually beneficial deals with these countries. This move is expected to enhance regional connectivity and economic development, signalling a promising future for trade between these nations.

PSW EXTENDS DIGITALIZED TRADE SERVICES TO PAKISTAN'S DRY PORTS



PSW has extended the scope of its digitalized operations to the dry ports of Pakistan. Traders can use the PSW system for the clearance of commercial imports of consignments being transhipped to and cleared from all Dry Ports of Pakistan except Quetta.

According to the circular issued by PSW, all items classified under Chapters 1 to 50 of the Pakistan Customs Tariff (PCT) will be subject to filing a Single Declaration (Imports) through the PSW system. However, for items related to the Department of Plant Protection (DPP), the Animal Quarantine Department (AQD), and the Federal Seed Certification and Registration Department (FSC&RD), the clearance will be subject to the electronic issuance of release orders from the respective regulatory department.

PANEL DISCUSSION ON THE 'REGULATORY FRAMEWORK OF PAKISTAN'



CEO PSW, Mr. Aftab Haider, participated in a panel discussion jointly organized by the Board of Investment (Bol), Pakistan Institute of Development Economics (PIDE), and Rasta (Research for Social Transformation and Advancement). The discussion, titled 'Regulatory Framework of Pakistan,' revolved around the provision of an enabling environment to businesses by overcoming various challenges faced by regulators and stakeholders.

Mr. Haider shared the efforts and achievements of PSW in reducing the regulatory burden in cross-border trade. He shared his insights about the regulatory controls, the need for National Single Windows (NSW), and how PSW, as a trade facilitation initiative, is enabling the trading community of Pakistan by reducing the time and cost of conducting cross-border trade. He also highlighted how PSW, as regulatory reform, fostered economic growth, attracted foreign investment, and improved the overall business environment in Pakistan.

PSW prioritizes the confidentiality of its users' information and firmly commits to data privacy. Only authorized users within the PSW system can access confidential documents and information. The system captures the particulars of users electronically, which is then only made available to traderelated regulatory bodies integrated with the PSW platform.

According to the Pakistan Single Window Trade Data Dissemination, Exchange, and Utilization Rules 2023, issued by Pakistan Customs, trade-related information, transmission, documents, data, or records gathered through the PSW are highly confidential. To ensure data confidentiality throughout the information-sharing cycle, Customs or any other public or private sector entities will place adequate measures to protect personal data, privacy, and confidentiality of individual records and transactions. Also, all stakeholders are required to prevent unauthorized transmission or sharing of information with other entities and individuals.


THE LOGISTICS ECOSYSTEM – A DIRECTORY OF LOGISTICS RESOURCES AT YOUR FINGERTIPS

In collaboration with the Sustainable Development Policy Institute (SDPI) and the SDPI Centre for Private Sector Engagement, PSW launched a webinar series called 'Trade Made Easy,' with the second series conducted in April under the theme, "Impact of Foreign Exchange and Letter of Credit Crisis on Industrial Growth."

Trading goods across international borders is riskier than trading within national borders. Deciding on whether the risk should be borne by one of the trading partners or shifted onto a bank by paying a fee to purchase a letter of credit (LC) is a critical decision. The webinar explored risk mitigation strategies using LCs and trade finance instruments that offer guarantees to trading partners.

The 3rd series of 'Trade Made Easy,' conducted in June, is titled "Pakistan's Service Trade in the International Market." This webinar aims to delve into the Strategic Trade Framework (STPF) 2020-25 seeking to enhance Pakistan's service trade by analyzing international demand trends in the service sector.

Traders, customs agents, and other stakeholders of Pakistan's trading community participated in the webinar and appreciated the efforts of PSW to revolutionize the cross-border trading experience in Pakistan.
